BSA Rules will apply. The tournament will be played with **BSA Approved Shuttles**. Should the amount of entries allow it, there will be a Consolation and Bowl event which will consist of **one game to 21 (sudden death at 20 all)** and will be played with **used feather shuttles**. Losers of matches must be prepared to umpire the following match, if requested. Food and refreshments will be available throughout the tournament.
