Entries: *All individual entries must be sent to their respective Provinces and a bulk entrylist must be sent from each Province to Brenda Boshoff not later than 16:30 on 25 October 2024 to bboshoff11@gmail.com.* BCA is implementing the Online Entry System for this tournament and we seek your cooperation to ensure all entries are submitted before the closing date. **No late entries will be accepted.**

BWF ID: Players cannot be entered unless they already have a BWF ID-number. In case you wish to enter players who do not have a BWF ID-number, please contact **Mike Noone** (baddies1@gmail.com 083 307 0595) well in advance of the tournament, so that the players concerned can obtain a BWF ID-number before the closing date of the tournament. **Withdrawals:** Withdrawal without penalty is Monday 25 November 2024. Players withdrawing after Monday 25 November 2024 or no-show will have to pay a fine of **R300 and R2000** respectively.

Conditions: The tournament will be played on a knock-out system and in full accordance with the General Competition Regulations of BWF and the instructions of Badminton Confederation Africa. Competitors must be prepared to play at the times determined for the events for which they have entered.

All prizes will be distributed during the official prize giving ceremony after the finals. Players shall not plan their departure before the prize giving ceremony; the organisers will not award medals and prize monies before the finals.

According to the BWF General Competition Regulations, there is no world ranking points for an International with less than 8 entries in (MS, WS, MD, WD and XD). In such a case, the tournament may be cancelled, and the organisers will not take any responsibility for any arrangements that may have been already made.

Clothing/advertising: Advertising on clothing and colour of clothing shall be according to BWF competition regulations. For circuit tournaments the player name on the back of the shirts is mandatory for the semi-/finals.
